		- Attended an OMAHA Zoom regarding U11 Dev playoffs - They will be creating an additional flight for playoffs rather than having teams go back to A, B or C. There was some confusion because it is not as straightforward as the Rep Tiers due to Dev being classified as Recreational.		



- The Affiliate Player process was also changed for U11 Dev. Originally the rule was that Dev teams could only AP from Rec. Now, A can pull from B, B can pull from C and C can pill from Rec.
- Photos are in and distributed to teams. Retakes are set for January 16th.
- Finally got a credit card there was an error with the online application form that caused a delay.
- The U13 Tournament team has had an initial ice time with another set for this week. The U11 Tournament team has their initial ice time tomorrow morning. Mike Brown and Cory Hintz are leading the U11 group and Sat Gill is leading the U13 group.

Some player movement was made in U18 with a player coming back from Junior. This caused a release from the U18 AA team and a player was moved from our U18 Tier 2 team to Rec.
